

ORDINANCE NO. 2472

**AN ORDINANCE PROVIDING FOR REGULATION OF NOISES
WITHIN THE VILLAGE LIMITS OF THE VILLAGE OF DENNISON, OHIO, REPEALING
ALL PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, AND
DECLARING AN EMERGENCY**

WHEREAS, it is the objective of the Members of Council of the Village of Dennison, Ohio to promote the peace and quiet enjoyment of areas within the territorial limits of the Village of Dennison, Ohio; and

WHEREAS, there are presently limited remedies available to the Members of Council of the Village of Dennison, Ohio to promote these goals of peace and quiet enjoyment.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF DENNISON, OHIO, AS FOLLOWS:

SECTION 1. Disturbing Sounds, Noises, or Performances in Public Places. It shall be unlawful for the Owner, Keeper, Manager or any person in charge or control of a Night Club, Restaurant, Dance or Amusement Hall, Tavern or other Public Place to engage in or permit the playing of musical or other instruments or the making of other noises in or about the premises in such a manner as to unreasonably and unnecessarily disturb the peace and quiet of the neighborhood after 11:30 PM. The charging document issued under this Ordinance shall state the specific date and time at which the offense is alleged to have occurred.

SECTION 2. Permit Required. A representative from a Night Club, Restaurant, Dance or Amusement Hall, Tavern or other Public Place must apply for a permit with the Village of Dennison, Ohio Zoning Inspector for any type of live outdoor performance to be performed within the Village of Dennison, Ohio, including, but not limited to, concerts, pageants, and auditions.

SECTION 3. Penalties. Whosoever violates any of the foregoing sections shall be punished as follows:

FIRST OFFENSE	WRITTEN WARNING
SECOND OFFENSE	\$100.00 FINE
THIRD AND SUBSEQUENT OFFENSES	\$300.00 FINE

SECTION 4. This ordinance shall take effect upon successful, required vote of the Members of Council of the Village of Dennison, Ohio, and at the earliest time allowed by law. This Ordinance is determined to be necessary to protect the welfare, health, and/or safety of the Village of Dennison, Ohio, and its inhabitants.
