

RESOLUTION NO. 2522

**A RESOLUTION DECLARING THE NECESSITY TO LEVY A TAX IN EXCESS
OF THE TEN-MILL LIMITATION
ORC. 5705.19, ORC 5705.191, ORC 5705.26**

The Village of Dennison of Tuscarawas County, Ohio met in regular session on the 19th day of July 2012 at the office of council chambers with the following members present

Greg DiDonato moved the adoption of the following resolution

Be It Resolved by the Village of Dennison Council of Tuscarawas County, Ohio, that

Section 1. The Board determines and declares that the amount of taxes which may be raised within the ten mill limitation will be insufficient and that it is therefore necessary to levy a tax in excess of the ten mill limitation for the benefit of Village of Dennison, Tuscarawas County, Ohio, for the purpose of Fire Truck Purchase at a rate not exceeding 2.5 mills for each one dollar of valuation for 5 years, and \$0.25 for each one hundred dollars of valuation for 5 years and which levy is an additional levy.

Section 2. The question of approving the levy shall be submitted to the electors of Village of Dennison at the election to be held on the 6th day of November, 2012, and that said levy be placed on the tax list of the current tax year, commencing in 2012, first due in the calendar year 2013, in compliance with the provisions of ORC 5705.34, if a majority of the electors voting thereon vote in favor thereof.

Section 3. The Fiscal Officer of this Board is directed to certify immediately a copy of this resolution to the County Auditor of Tuscarawas County requesting that the County Auditor certify to this Board the total current valuation of the Village of Dennison and the dollar amount of revenue that would be generated annually by the 2.5 mill levy.

Section 4. It is found and determined that all formal actions of the Board concerning and relating to the adoption of the resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in, meetings open to the public, in compliance with law.
